This ultrasound gel features Carbopol® ETD 2020 NF polymer which imparts viscosity and clarity to the formulation. Carbopol® ETD 2020 NF polymer is an easy to disperse copolymer designed to produce aqueous dispersions which are less susceptible to agglomeration. The gel is intended to be used with medical ultrasound equipment to reduce the impedance between the electrode surface and the skin.

Procedure

- Disperse Carbopol® ETD 2020 NF polymer in water (Part A).
 {Refer to <u>TDS-187:</u> Carbopol® ETD 2020 Polymer and <u>TDS-207:</u> Carbopol® ETD Polymers Formulation Tips}
- Disperse sodium carboxymethylcellulose in propylene glycol, add water and mix thoroughly until a clear, viscous solution is obtained (Part B).
- 3. Add Part B ingredients to Part A ingredients, and mix thoroughly.
- 4. Dissolve disodium EDTA and sodium parabens in water, and add the salt solution into the Part A + B mixture (Part C).
- Neutralize the above mixture with 18% sodium hydroxide solution and adjust to weight with deionized water (Part D).
