1. PURPOSE

The Lubrizol Corporation (Lubrizol) is committed to a policy of responsible citizenship, including the sustainability of and respect for the environment.

2. SCOPE

This policy applies to all Lubrizol facilities and operations, the procurement of materials and Lubrizol's Community Investment.

3. ADMINISTRATION

Lubrizol is committed to environmental sustainability and, to the best of its ability, meeting the sustainability expectations of its stakeholders including its employees, customers, suppliers and commercial partners, its parent company and the communities where we work and live.

Lubrizol recognizes its responsibility to reduce the environmental impact of its operations. To align how we work with our commitment and responsibility, Lubrizol will:

- Comply with all applicable environmental laws, regulations and directives regarding waste, air emissions, hazardous materials, and wastewater discharge
- Use resources in an efficient and responsible manner
- Set environmental goals and targets to:
 - Reduce Lubrizol's Scope 1 and 2 emissions, drive the efficiency of Lubrizol's energy usage, and reduce reliance on fossil-based energy;
 - Reduce Lubrizol's waste intensity (waste to landfill); and
 - Foster responsible water stewardship through biannual water risk assessments and ongoing water stewardship activities, especially at sites and locations in water-stressed areas.

- Measure, track and regularly report Lubrizol's progress to achieving its environmental goals and targets.
- Identify opportunities to incorporate reused or recycled (nonvirgin) materials in the manufacture of Lubrizol products.
- Identify and take action to avoid negative environmental impacts such as deforestation and destruction of local biodiversity.

Lubrizol is committed to incorporating more renewable materials, including bio-based, natural, derived-natural, and plant-based, in its portfolio of products. As a buyer, Lubrizol clearly communicates its expectations that suppliers will join Lubrizol in its commitment to reducing the risk of negative consequences from sourcing renewable materials, such as interruption of biodiversity, deforestation, and unfair labor practices. These expectations are set forth in Lubrizol's Supplier Code of Conduct.

In addition to its operations and procurement activities, Lubrizol recognizes its responsibility as a corporate citizen in the communities where we work and live. Lubrizol is committed to positively impacting these locations through its Community Investment strategy by:

- Prioritizing Community Investment activities and investments that align with and contribute to the United Nations Sustainable Development Goals 13 (Climate Action), 14 (Life Below Water) and 15 (Life on Land)
- Conduct employee engagement and volunteer activities that positively impact the local natural environment, including water stewardship and biodiversity preservation
- Direct investment of corporate philanthropic resources to support organizations and activities with missions that align with UNSDGs 13, 14 and 15
- Foster and support the commitment Lubrizol's community partners, including educational institutions and nonprofit organizations, to sustainability, environmental stewardship and UNSDGs 13, 14 and 15
